March 10, 2012 MU-101: Equipping to Share: Everyday Evangelism

During section one, we will identify witnessing hindrances, tackle how we can overcome these obstacles to faith-sharing and discuss the importance of prayer in everyday evangelism.

Section two will explore the mission we have been given, the message we are to carry forth and the privileged role God has assigned us.

In section three, we will look at everyday opportunities for sharing Christ. We will learn to identify a person's worldview in order to connect with his or her heart. We will discuss the importance of being Spirit-led to be an effective witness. We will also learn ways to witness in brief encounters.

Section four will focus on how we can witness within long-term relationships to family members and friends as well as how to be a Christian witness during times of crisis. You will also learn to personalize your witness, utilizing Scripture to become ready to respond to a person's "Yes" or their "No."

April 14, 2012 MU-102: Witnessing Methods: Seven Styles of Faith-Sharing

Section one will reveal the seven styles of faith-sharing and tackle how to utilize the first two styles: Lifestyle Witnessing and Relational Witnessing.

Section two will focus on styles three and four: Testimonial Witnessing and Situational Witnessing. You will also be stretched to consider your personal testimony.

Section three is centered on the last three styles: Servanthood, Invitational witnessing and Utilizing Witnessing Tools. You will put your knowledge to work through a video case study.

In section four, you will identify your natural style, recognize and apply yourself to a secondary style and learn to determine an appropriate and effective style in each everyday situation.

May 12, 2012 MU-201: Dealing with Tough Questions

Section one will reveal the truth about cultural opposition to Christianity in America, including what is displayed in the media. We will discuss the recent rise of other religions and how to share the one true God in a world full of alternatives.

In section two, we will learn to identify the root of a question. We will also discuss those tough questions prevalent in society today such as "Why do bad things happen?" and "Why does God say, 'No'?"

In section three, we will discuss what to do when you cannot think of an answer to a difficult question. We will also tackle tough objections and discuss the more common objections and how to deal with them.

In section four, we will discuss the art of apologetics. How helpful is arguing, really? We will also get down to the common source of every objection: spiritual warfare.
